CITY & BOROUGH OF WRANGELL ABSENTEE BY-MAIL BALLOT APPLICATION

GENERAL INFORMATION

- 1. Municipal elections are held annually the first Tuesday in the month of October to elect borough officials and any ballot propositions or issues.
- 2. You may apply for absentee by-mail ballot for any or all elections conducted by the Borough as long as the ballots for each election will be sent to you at the same address. [The Primary and General Elections are conducted by the State of Alaska. To vote by-mail in those elections, apply directly to the Alaska Division of Elections, Absentee Voting Office, 619 E. Ship Creek Avenue #329, Anchorage, AK 99501-1677. Phone: (907) 375-6400]
- 3. If you will be in the City of Wrangell within 15 days before the election, you may prefer to vote **absentee in-person** at the Borough Clerk's Office, 205 Brueger Street. Please call if you have any questions 907-874-2381.

INSTRUCTIONS

<u>Absentee Voting - By Mail</u> Your application must be received at least ten (10) days prior to the election. **APPLY EARLY** to be sure you receive your ballot in time.

<u>Absentee Voting - Electronic Transmission</u> You need to use the Absentee By-Fax Application. The Absentee By-Fax Application must be received not less than the day immediately preceding the election.

Complete ALL information requested. The ballot may be completed on-line and printed out. You **MUST** provide your <u>residence address in the City & Borough of Wrangell</u>. Use the description of the physical location - street number, milepost, trailer court and space number, etc.

SIGN your application. This is a requirement of law. [Another individual may apply for an absentee ballot on behalf of a qualified voter if that individual is designated to act on hehalf of the voter in a written general power of attorney or a written special power of attorney that authorizes the other individual to apply for an absentee ballot on helalf of the voter. A copy of the power of attorney must accompany the absentee ballot application.]
