## ABSENTEE BY-MAIL BALLOT APPLICATION

### GENERAL INFORMATION

1. Municipal elections are held annually the first Tuesday in the month of October to elect borough officials and any ballot propositions or issues.
2. You may apply for absentee by-mail ballot for any or all elections conducted by the Borough as long as the ballots for each election will be sent to you at the same address. [*The Primary and General Elections are conducted by the State of Alaska. To vote by-mail in those elections, apply directly to the Alaska Division of Elections, Absentee Voting Office, 619 E. Ship Creek Avenue #329, Anchorage, AK 99501-1677. Phone: (907) 375-6400*]
3. If you will be in the City of Wrangell within 15 days before the election, you may prefer to vote **absentee in-person** at the Borough Clerk's Office, 205 Brueger Street. Please call if you have any questions 907-874-2381.

### INSTRUCTIONS

Absentee Voting - By Mail Your application must be received at least ten (10) days prior to the election. **APPLY EARLY** to be sure you receive your ballot in time.

Absentee Voting - Electronic Transmission You need to use the Absentee By-Fax Application. The Absentee By-Fax Application must be received not less than the day immediately preceding the election.

Complete ALL information requested. The ballot may be completed on-line and printed out. You **MUST** provide your residence address in the City & Borough of Wrangell. Use the description of the physical location - street number, milepost, trailer court and space number, etc.

**SIGN** your application. This is a requirement of law. [Another individual may apply for an absentee ballot on behalf of a qualified voter if that individual is designated to act on behalf of the voter in a written general power of attorney or a written special power of attorney that authorizes the other individual to apply for an absentee ballot on behalf of the voter. A copy of the power of attorney must accompany the absentee ballot application. ]
